The chairman was informed that the all quoted item of M/s Mediland Pakistan (Pvt) ltd. was rejected on following grounds.

Item No 1 to 09	Item was rejected due to Poor quality and tips overlaps.
Item No 10 to 28	Item was rejected due to Tips overlap & don't approximate properly, Tip too long & lose holding power, Forceps overlap & don't hold tissue properly, Scissor's Sharpness not well, Poor quality and tips overlaps Clamp jaw overlap
Item No 30 to 53	Item was rejected due to Stiff Instrument short length, Stiff Instrument blends scissor & short length, Holding power not well stiff instrument short length, overlapping of tip & short length, heavy weight & blend

DECISION

By keeping in view, the grievance of M/s Mediland Pakistan (Pvt) ltd. is turndown and the decision of TAC remains intact.

2. M/s Meditools International

The firm was non-responsive due to shortage of following documents which was required in Knock out Clauses:

- Valid National Tax Number. i.
